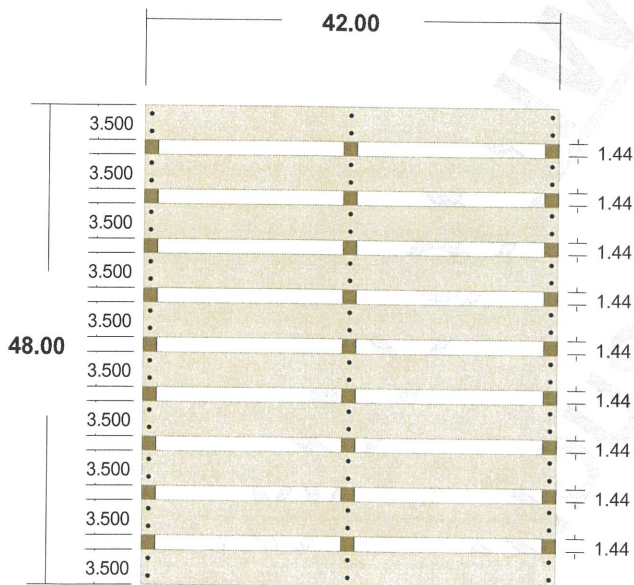
Side View



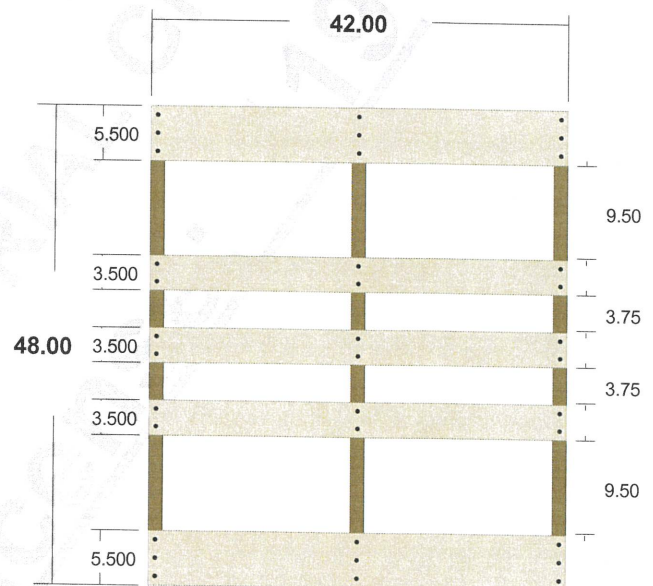
End View
